Permit Conditions for Camping Areas 1–7

This permit provides written authorization for the Permit Holder to:

1. use a motor vehicle, excluding an off-highway vehicle and any similar specialized means of conveyance, off of the highway for the purpose of camping in a Designated Camping Area; and
2. camp within a Designated Camping Area pursuant to sections 26(b) and 32 of the Provincial Parks (General) Regulation, Alta Reg 102/1985 and subject to the terms and conditions contained in this Permit.

The Permit Holder acknowledges that in addition to the requirements of this Permit, they must comply with requirements contained in the Provincial Parks Act, RSA 2000, c P-35, the Provincial Parks (General) Regulation AR 102/85 and all other applicable legislation, as amended or replaced from time to time.

- Camping is all first-come, first-served, and there is no charge for the permit
- Camping must not exceed 16 consecutive nights. Checkout time is 2 p.m.
- Camping must be within marked areas as identified on maps and signs
- Campsites should be at least 30 metres away from moving water, wetland or standing water body
- Clearing of vegetation is not permitted. This includes trees, branches, bushes, rocks and fallen logs
- Sensitive areas may be specifically excluded, as marked, within the Designated Camping Areas
- All campfires must be fully contained in designated fire pits and must not be left unattended
- All food and garbage must be stored in bear-proof containers or vehicles
- Sewage dump stations are located in the town of Pincher Creek and the Crowsnest Pass
- Off Road Vehicles (OHVs) are only permitted on signed and designated trails.
- A conservation officer may cancel this Permit under Sec 42. of the Parks Act by providing notice to the Permit Holder of the cancellation

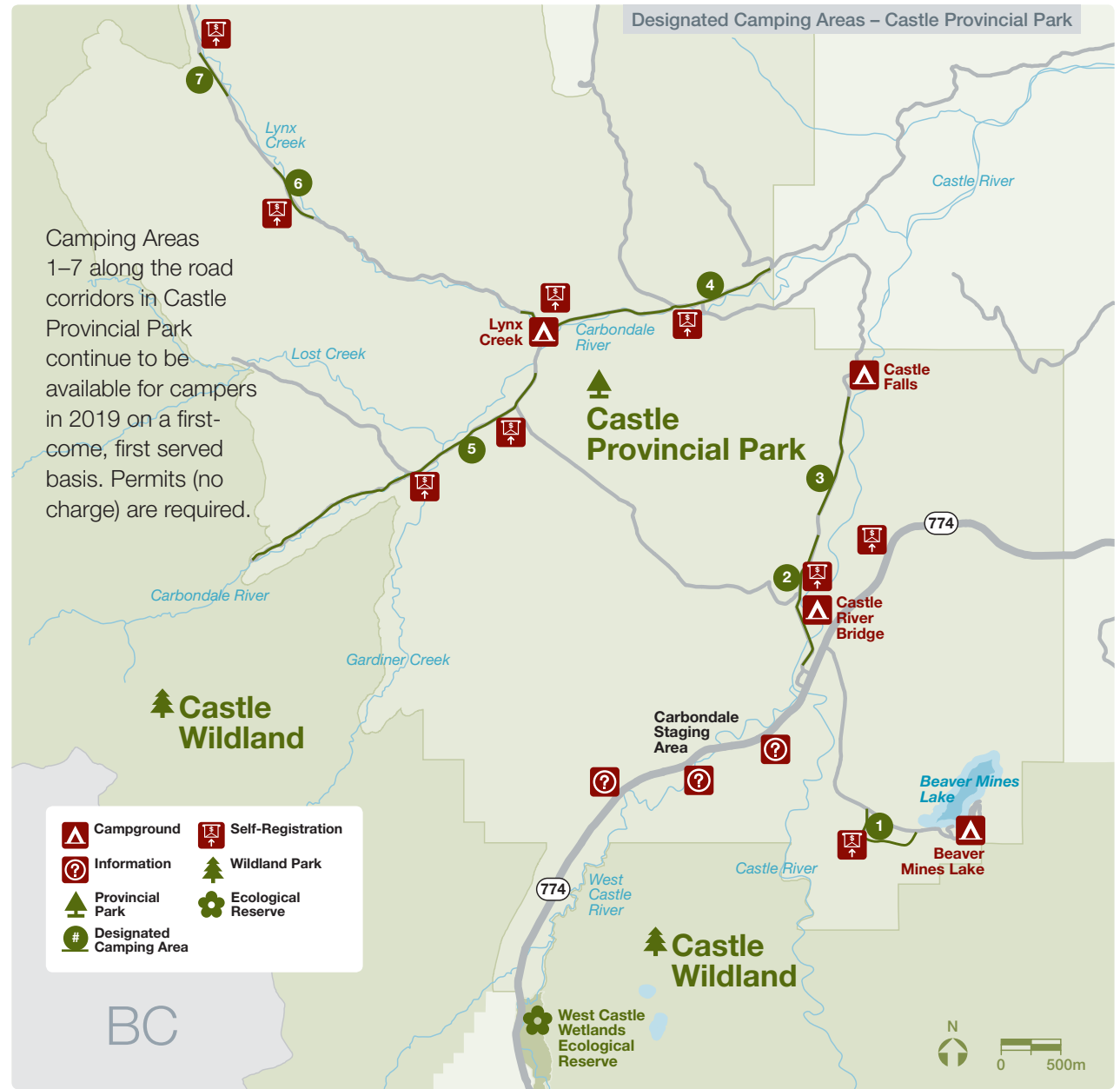
